#### **CHAPTER TEN – JAMES WILSON MCGEE FAMILY**

Generation No. 3

**1. JAMES WILSON<sup>3</sup> MCGEE** (*JOHN SIMPSON<sup>2</sup>*, *JOHN<sup>1</sup>*) was born June 06, 1861 in Bexar County, Texas, and died February 27, 1938 in Horse Cave, Hart County, Kentucky. He married **EVALENA HODGES** December 28, 1889 in Horse Cave, Hart County, Kentucky, daughter of JEFFERSON PAUL HODGES and ELIZABETH M. WALTON. She was born March 25, 1867 in Hiseville, Barren County, Kentucky, and died July 24, 1963 in Louisville, Jefferson County, Kentucky.

Notes for JAMES WILSON MCGEE:

James Wilson McGee was called "Pa Gee" by his family. He was the namesake of James C. Wilson (1816-1861), a Texas state senator and itinerant Methodist preacher for whom Wilson County, Texas was named.

The 1900 census for District 55, Horse Cave, Kentucky lists **James McGee**, age 38, his wife, Lena, age 32, a daughter, Reminta, age 9, a daughter, Katie, age 6, a daughter, Pricie A., age 3, and a son, James S., age 1. Lena had had 4 children, all of whom were still living. Also living in the household was his mother, Ann R. McGee, age 80, a widow. The census record indicated that Ann had given birth to 13 children, 10 of whom were still living, and her parents were both from Virginia.

James W. McGee was elected Hart County Tax Commissioner in 1909 and served in that capacity from January 1, 1910 until January 1, 1918.

The 1910 census for District No. 2, Horse Cave, Hart County, Kentucky lists **Jim W. McGee**, age 44, head of the household, a harness maker and owner of a general hardware store, his wife, Lena, age 45, manager of a rooming house, a daughter, Katie, age 15, a daughter, Pricie, age 13, a son, James S., age 11, and a daughter, Ruth M., age 10. The couple had been married for nine years, and all five of their children were still living. In addition to the immediate family, eight men were listed as roomers in the household.

The 1920 census for Horse Cave, Hart County, Kentucky lists **James W. McGee**, age 59, a saddler, his wife, Lena, age 53, a milliner, a son, James S., age 21, a laborer, and a daughter, Ruth, age 19. The family resided on College Street. James owned his own shop.

The 1930 census for Horse Cave, Hart County, Kentucky lists **James W. McGee**, age 68, head of the household, owned a repair shop with shoes and harness, his wife, Lena, age 63, manager of a millinery shop. The couple lived in a home on Main Street.

By 1889, Rev. John S. McGee was in very poor health, and it was decided that his son, James W. McGee would become the principal caretaker for his parents, thereby ensuring that they would be cared and provided for in their old age and infirmity. An agreement was drawn up by John S. McGee (later proven and recorded by the Hart County Court as his last will and testament),

which specified that James would receive fifty acres of land including the family home and all out-buildings, but that both of his parents would still have the freedom and run of the house until their deaths. James W. McGee married Lena Hodges on December 28, 1889, and they moved in with his parents at Clear Point, Kentucky. Rev. John S. McGee died three months later on March 28, 1890. James, his wife, Lena, and his mother, Ann, continued to live at the family farm until about 1895, when they moved to the nearby town of Horse Cave, Kentucky.

James W. McGee's trade was saddler and harness maker. He ran his business from a shop in downtown Horse Cave, where he made, repaired and sold saddles and other furnishings for horses. According to family oral history, he was bitten by a horse, and when the wound turned septic it became necessary to amputate his left leg in order to save his life. He also carried a scar on his face, the result of a bite from another horse. Both he and Lena were strong in their religious beliefs and were active members of the Horse Cave Methodist Church throughout their lives.

MR. JAMES W. MCGEE DIES, obituary dated February 27, 1938.

Mr. James Wilson McGee died at his home in Horse Cave Sunday morning at 11:50 o'clock. Mr. McGee had been in declining health for the past two years. He was the son of the late Rev. John Simpson McGee, who was an active minister from 1842 to 1889 and served as Presiding Elder of the Bowling Green District. His mother was Mrs. Anne Reminta Hawkins McGee.

Mr. McGee was born June 6, 1861, and was united in marriage to Miss Lena Hodges Dec. 28, 1889.

In 1909, Mr. McGee was elected on the Democratic ticket as Tax Commissioner, reelected in 1913 and served Hart County in that capacity for eight years, Jan. 1, 1910 to Jan. 1, 1918.

The deceased is survived by his wife and five children: Mrs. Porter Nichols and Mrs. Grover Marshall of Horse Cave; Mrs. John Bolt of Laurens, S. C.; James Smith McGee of St. Petersburg, Fla; and Mrs. Luther Goren of Elizabethtown; all of whom were at the bedside when the final summons was answered. He is also survived by several grandchildren and great grandchildren. The death of Mr. McGee is the first in four generations, including the in-laws, all of which number thirty two.

Mr. McGee was a member of the Methodist church. Funeral services were conducted at the residence of his daughter, Mrs. Nichols, Monday afternoon at 8 o'clock; interment in the Horse Cave cemetery, where his mother and father are also buried.

Following is a transcription of James W. McGee's last will and testament, dated January 9, 1934. The original was hand written in his presence by Caroline Withers and is signed with an "X" by J. W. McGee. The two-page document is currently in the possession of a great granddaughter, Suzi (Ball) Everitt.

Last will and testament of J. W. McGee

I, J. W. McGee, of Horse Cave, County of Hart, state of Kentucky, being of full age and of sound mind and memory, do make, publish and declare this to be my last will and testament, hereby revoking all wills by me heretofore made.

Item 1: I direct that all my just debts and funeral expenses be paid out of my estate as soon as practicable after the time of my decease.

Item 2: All the property, both real and personal of every kind and description, where so ever situated, which I may own or have the right to dispose of at the time of my decease, I give, bequest and devise to my wife, Mrs. Lena McGee, so long as she remains single and is loyal to me through life, for her entire lifetime, same to be kept for her support and comfort outside of business projects with the advise and care of the children, as her own during her life as aforesaid and on the conditions here to fore named.

Item 3: Upon the death of my said wife, said property shall revert to my heirs, each sharing equally in the distribution thereof.

Item 4: I make, nominate and appoint Lena McGee my wife to be the executor of this my last will and testament, and I request that no bond be required of her as such. I further request that no inventory be made or taken in so far as the same may be lawfully omitted.

Dated at Horse Cave, Kentucky this 9<sup>th</sup> day of January 1934.

(Note: The reason why James McGee did not sign his name to the above document instead of "making his mark" is not clear. He was certainly able to read and write as demonstrated by the many letters he wrote to his wife during their courtship. He lived until 1938, four years after his will was written, so perhaps he had been in ill health at the time it was drawn up.)

Notes for EVALENA HODGES:

She was called "Ma Gee" by the family.

The 1870 U.S. Census for Center, Metcalfe County, Kentucky lists Jefferson P. Hodges, age 39, head of the household and a physician, his wife, Eliza M., age 34. a son, Wilder, age 4, a daughter, Lena, age 3, and a son, Frank W., age 1. The family's real estate was valued at \$1800. and their personal estate at \$500.

After her mother's death in 1877, Lena Hodges and her brother, Wiley, were sent to live with their uncle, Dandridge Walton and his family near Hardyville, Kentucky. (Note: There were two different individuals with the name Dandridge Walton, who resided in Hart County in 1880. There was Dandridge Walton, born in1859, who was the son of James C. Walton and the brother of Sarah Walton. Sarah Walton married William D. McGee, the brother of James W. McGee. There was also Dandridge Walton, born in 1851, the son of George S. Walton and the brother of Elizabeth Walton. Elizabeth Walton was the mother of Lena Hodges, who married James W.

McGee. Both individuals named Dandridge Walton were almost certainly related, probably cousins, but the exact nature of their kinship is not known.)

The 1880 census for Hardyville, Hart County, Kentucky lists Dandridge F. Walton, age 29, a minister and a farmer, his wife, Corrind, age 29, a daughter, Olla, age 6, a daughter, Ora, age 3, and a daughter, Lizzie, age 8 months. Also living in the household were a cousin, Harlan James, age 22, a farmer; a nephew, Wiley Hodges, age 14; and a niece, Lena Hodges, age 13.

On June 23, 1887, Miss Lena Hodges was granted a Certificate as a qualified Teacher for the Common Schools of Hart County for a period of two years expiring on June 30, 1889. The certificate was signed by B. C. Gardner, County Superintendent, and W. F. Rogers and H. A. Martins, Examiners.

For many years Lena McGee had a millinery shop in the town of Horse Cave, Kentucky where she designed, made and sold women's hats.

#### MRS. LENA McGEE AGE 96 DIES

Mrs. Lena McGee, age 96, a former resident of Hart County, but who had lived in Louisville for about twenty years, passed away Wednesday at 1:30 p.m. at "Geriatrics Center," Waverly Hills Pleasure Ridge Park.

Mrs. McGee was born March 25, 1897, and was the daughter of Dr. Jefferson Paul Hodges and Eliza Mildred Walton Hodges. She was a member of the Horse Cave Methodist Church for 78 years and had retained her membership there and is its oldest member. She was also a member of Horse Cave Chapter of Eastern Star No. 258.

She is survived by four daughters, Mrs. Minta McMullen and Mrs. Ruth Lawrence, of St. Petersburg, Florida, Mrs. Pricie Richardson, Horse Cave, and Mrs. Katherine Bolt, Laurens, South Carolina; one daughter-in-law, Mrs. Lera McGee, wife of her deceased son, James S. McGee; also twelve grandchildren, 26 great grandchildren, and ten great-great grandchildren, and three nieces.

Funeral services will be held at Winn Funeral Home, Horse Cave, at 2:00 p.m. (CST) Friday, by Rev. Conn, pastor of Horse Cave Methodist Church, with interment in Horse Cave Cemetery.

He was born 1893, and died 1966.

Notes for MARY REMINTA MCGEE:

"Minta" McGee was born at the McGee family farm near Clear Point, Kentucky (now called Uno) in Hart County. Her parents had moved into the John McGee home place immediately after their marriage in order to help care for her grandparents in their old age. John McGee died three months later, in March of 1890, and her grandmother, Ann Reminta McGee would continue to live with her parents for the next eleven years until her death in 1901. About 1895, the family moved into the town of Horse Cave, where Minta grew up and attended school. She was a member of the Horse Cave Girl's Band.

Notes for PORTER ELLIS NICHOLS:

Porter Nichols was voted "The Most Handsome Man In Horse Cave" when he was a young, single man. Many years later, two of his children, Royce Nichols and Nina Nichols, were voted "Best Looking Boy" and "Best Looking Girl" in Horse Cave when they were in high school.

Bessie Lou (Nichols) Sturgeon tells this story about Porter when she was a little girl:

"In those days, everybody always went to town (Horse Cave) on Saturdays, and Porter would always be in town on Saturday afternoons. My brother and sister and I would always watch and try to catch Cousin Porter when he was talking to Daddy in town on the street corner, and then we'd go up to Daddy and say, 'Can we have a nickel?' Cousin Porter would always reach into his pocket before Dad could say anything and give us each a nickel, and he'd say, "Now run and go buy you some ice cream." We had that routine worked out pretty good, and we'd work it every Saturday. On Saturdays Daddy would usually give each of us a quarter to spend in town. Well, in those days a movie would cost 9 cents, popcorn was another 5 cents, and a coke was 5 cents. That left us 6 cents to spend on candy and ice cream. When we would finally run out of money, and it still wasn't time to go home, we'd start looking for Porter and Daddy."

The 1920 census for District No. 2, Hart County, Kentucky listed "Pater" E. Nichols, age 42, head of the household, his wife, **Minta M**., age 29, a son, Royce C., age 12, a daughter, Nina M., age 10, a son, Pater Jr., age 8, and a daughter, Ruth A., age 4. The family rented their home.

The 1930 census for Horse Cave, Hart County, Kentucky listed Porter E. Nicholds, age 52, head of the household and employed as a mechanic, his wife, **Minta**, age 39, boarding, a son, Royce, age 22, a clerk in the post office, a daughter, Nina, age 20, a son, Porter, Jr., age 18, worked in

a cream factory, a daughter, Ruth, age 14, a daughter, Jeanette, age 9, and a daughter, Dortha, age 5. The family rented their house which was located on Main Street.

Taken from The Hart County Herald, "40 Years Ago – 1920."

W.B. Munford writes for the Herald just as things look to him. Here is one thing that strikes him and he says, "Mr. Porter Nichols has a house full of children that are as orderly as soldiers under marching orders, and they obey their parents to a fraction."

During World War II, in 1944, at the age of 66 years old, Porter Nichols served in the Auxiliary Military Police of the U.S. Army. His duties were as Watchman for the National Synthetic Rubber Corporation, Louisville, Kentucky.

TWO PERSONS KILLED IN CAR WRECK HERE (The Americus Times Recorder, May 21, 1953.)

Sumter County, Fla. A 63 year-old man and two year-old child were killed and three persons injured, one critically, when the driver lost control of a passenger car and hurtled off the road 415 feet crashing into a tree Wednesday about 4:10 p.m., 2.1 miles west of Americus on the Plains Road.

Dead were Manuel Fernandez, Tampa Fla., cigar manufacturer, and little Donald Ball, Gainesville, Fla. Critically injured was Miss Ruth Lawrence, about 40, of St. Petersburg. Mrs. E.A. Ball, about 35, and Susie Ball, three, mother and sister of the fatally injured child were also injured and are in "fair" condition today. All three were admitted to the Americus and Sumter County Hospital.

The two deaths marked the first on the highway this year in Sumter County. They were the 14th and 15th in this area of the Americus State Patrol.

Sgt. W.D. Cochran, of the Americus State Patrol unit, who investigated the accident, reported that Mr. Fernandez, driver, was heading west on U.S. 280 when he lost control of the car, a 1950 Chevrolet ---- running off the road, knocking down a cement fence post and striking a tree near a tenant house. Mrs. Ball and her daughter were thrown from the car before it came to a halt against the tree, it was reported. The others remained in the car.

H.E. Sutton, 617 Elm Avenue, an eyewitness to the disaster, reported that he saw the Fernandez vehicle run off the road for a short distance before swinging back onto the highway and then hurtle again off the right-of-way. Frank D. Grossman, Arlington, Va., who was driving immediately behind Mr. Sutton, gave a similar account to Times-Recorder reporters on the scene.

Sgt. E.A. Ball, father and husband of the dead boy and injured woman, arrived in Americus early this morning from Gainesville where he is stationed in the Air Force. Sgt. Ball told the Times-Recorder by phone last night from Gainesville that his wife and two children had caught a ride with Mr. Fernandez, who was going to Louisville, Ky., in order to attend the graduation of Mrs. Ball's niece in Elizabethtown, Ky.

The body of Mr. Fernandez will be returned to Tampa tonight. Arrangements are not complete regarding the child.
