CHAPTER SEVEN – JOSEPH FLOOD MCGEE FAMILY

Generation No. 3

1. JOSEPH FLOOD³ MCGEE (*JOHN SIMPSON*², *JOHN*¹) was born December 12, 1854 prob. in Bexar County, Texas, and died October 25, 1928 in Houston, Harris County, Texas. He married **EMMA JOSEPHA MORRIS** December 23, 1880 in San Antonio, Bexar County, Texas, daughter of WILLIAM JACKSON MORRIS and CASANDRA RUTH MIDDLETON. She was born February 1859 in Jasper County, Mississippi, and died October 20, 1946 in Dallas, Tarrant County, Texas.

Notes for JOSEPH FLOOD MCGEE:

Joseph Flood McGee was the namesake of Joseph Flood, a farmer and resident of Shelby County, Kentucky where Rev. John McGee was assigned as an itinerant minister during the year 1852.

In 1866, Rev. John Simpson McGee, his wife, Ann, and six of their children, departed Texas for the final time and returned to Kentucky. Their four oldest children, Medley, Richard, Alice and Permelia, all remained behind, having married into local Texas families. At age 12, Joseph F. McGee was one of the six children who returned to Kentucky, and in the 1870 U.S. Census, he was listed as part of his father's household in the Hardin County, Kentucky. Sometime in the late 1870's, Joseph F. McGee returned alone to south-central Texas, and in the 1880 U.S. Census, he was residing with his sister, Alice (McGee) Trainer, and her family in Bexar County, Texas.

The following two-page letter was written by Ann McGee from their farm in Clearpoint, Hart County, Kentucky to her son, Joseph F. McGee, who at the time was residing with his sister and brother-in-law in Bexar County, Texas.

April 4th, 1880 Clearpoint

Joseph McGee

My dearest son this beautiful Sabbath day finds your old Ma Ma at home as usual but not well. I have been sick. At one time I thought you would see me no more in this world. They sent to the Cave for a doctor. A new doctor come there since you left by the name of Gerven The best Dr. in the county. I am much better now but I think these spells will suddenly take me away yet someday. I am taking medacin every day, sometimes 3 times a day. Jo I would love to see you all before I die, then I think I would not care much when I should go. Well Jo your Pa and the boys have bought the Crain place gave eleven hundred dollars for it get possession next Christmas have the liberty of sowing grain on it this fall. Every thing looks beautiful here now the five plums in full bloom all the fruits that your Pa set out when he came out here look fine you would hardly know the place every person says it improves so much we are done stripping tobacco will have four or five hogshead all the land we have is in wheat rye & clover & grass except that we intend putting in corn & tobacco & has good fencing nearly all around: George Green & Ann Taylor has married and rented our town Cave property. Can get you plenty of work here.

Mrs. Conway is dead and Mrs. Roddy and Mr. Conway have married - they married just three months after her death. It has been raining here for four days _____ do hope it will not reach you____ to take care of my harp - But I know you will do just as well and would. Darling remember the promise you made to me.

Don't be angry with me Darling When I ask you not to drink Pause and look into the future O my darling stop and think.

Think Dear of thy absent Father Who oft hath plead with thee To forsake the paths of sin and vice And a <u>noble man to be</u>

Think too of thy aged mother And the tears that she would shed If she knew her darling boy Could be by intemperance led

Pause and think my darling Of the one who loves you best Of the many prayers she offers Ere his eyes have sunk to rest.

Mrs. Rice has six children left for her to care and labour for & bad ones at that they tell me. Well I will close by sending my best love to all the family. Tell Medley to write & all of them. I owe Annie a letter.

Good by my love Ann McGee

The 1880 census for Precinct No. 13, Bexar County, Texas lists James Trainer, age 45, a farmer; his wife, Alice, age 35, keeping house; a daughter, Amelia, age 13; a daughter, Ante, age 11; a daughter, S. Belle, age 8; a daughter, Lillian, age 6; a son, James, age 1; a daughter, M. Alice, b. in April; and a brother-in-law, Joseph McGee, age 25, a farmer.

(Note: the child listed as "son" James Trainer, age 1 yr., was really a daughter, James Mary Trainer.)

On December 23, 1880, Joseph F. McGee, age 26, married a young teacher, Emma J. Morris, age 21, in Bexar County, Texas. Emma was the daughter of Dr. William J. Morris, a medical doctor and educator, who had relocated to Bexar County from Fayette County, Texas several years earlier. They were married in her father's home in San Antonio. For several years after their marriage, they resided in neighboring Wilson County, and their second child, Allie McGee, was born in Stockdale on June 23, 1883.

The following letter, dated September 9, 1881, was written by Emma to her husband, Joseph McGee:

Sep. 9th, 1881

Mr. Joseph F. McGee

My Darling Husband

I hardly know whether to write or not yet it seems almost impossible to wait longer. Today I am feeling worse than I have since I arrived here. My health is so much better than at Weatherford that I can't complain. Pa has failed to get a house for _____. I am now at Bro. Meds. He came to the Springs last _____ morning after me just as soon as he heard I was there. Oh I could not have been more rejoiced to have meet my own Bro. I stood the trip much better than I thought possible. Found Ozelda at the Springs. She is married to a nice man I think. I like him

also Frank. O darling I felt so anxious about <u>you</u>, but for the faith I have in an <u>All wise power</u> I could not stand it. I pray for you daily – yes hourly send up a petition on high – that God will protect <u>my loved one</u> and bring him through safe. Pa came to see us this morning. He is trying to rent a house in Stockdale until you come. Every thing is waiting on you. Bro. Med says that God will guard her husband from the tempters cruel snare, that He will ever give him courage, the right to do, and Satan dare.

I have not yet received a word from you but anxiously await this evenings mail thinking it will bring some tidings of my loved one. I will not write more for fear you miss it. Will write again to Austin.

May God bless you my Darling and shield you from all harm is the prayer of your loving wife.

It is believed that Joseph F. McGee was present when his father, Rev. John Simpson McGee, died in Kentucky in March 1890. Sometime between 1885 and 1890, Joseph McGee left Texas with his young family and returned to Hart County, Kentucky where he would make his home for the next several years. Joseph and Emma's fourth child, Joseph Bascom McGee, was born in Hart County, Kentucky on May 8, 1890, and census records show that their next child, Bryant McGee, was born in Kentucky in June 1892.

Joe and Emma McGee did not remain in Kentucky because by the time their sixth child, a daughter, Sammie, was born, in April 1896, the family had returned to Texas and had settled in Harris County.

The 1900 census for Precinct No. 8, Harris County, Texas lists **Joseph F. Maggee**, age 45, head of the household and a farmer, b. in Texas; his wife, Emma J., age 40, b. in Louisiana; a daughter, Ozie, age 18, b. in Texas; a daughter, Allie R., age 16, b. in Texas; a son, Kirbie F., age 15, a farm laborer, b. in Texas; a son, Joseph B., age 12, b. in Kentucky; a son, Bryan, age 8, b. in Kentucky; a daughter, Samie, age 4, b. in Texas; and a daughter, Ruby L., age 1, b. in Texas. The couple had been married for approximately 20 years.

(Note: In the above census report, the baby girl, Ruby L., age 1, born November 1899 in Texas, was listed as a daughter of Joe and Emma McGee. That information was incorrect, because Ruby was actually an orphan, the daughter of Emma's younger sister, Christine. Christine Morris married W. F. Brooks on June 29, 1881 in Wilson County, Texas, and they had two children, Ruby and Elmo Brooks. The children were orphaned when both of their parents died for reasons unknown, and they were taken in to be raised by their aunt and uncle, Alief Ozelda Morris and her husband John Magee (no relation to the McGee family of this report). When Alief Ozelda died in 1899, Joe and Emma McGee temporarily took charge of Ruby until the children's uncle, John Magee, could make arrangements to care for them himself. Later John Magee would raise both children as his own.)

The 1910 census for Houston, Harris County, Texas lists **Joe McGee**, age 56, head of the household and a farmer, his wife, Emma, age 51, a son, Bascom, age 20, farmhand, a son, Bryant, age 18, farmhand, a daughter, Sammie, age 14, and a daughter, Inez, age 10. The couple had been married for approximately 30 years, and seven of their ten children were still living. Also living in the household was a son, Kirby McGee, age 25, a farmhand, a daughter-in-law, Mattie, age 20, and a grandson, Lawton Eager, age 8. They had been married for approximately 1 year. (Note: The grandson, Lawton, was the child of their daughter Allie Eager, who was divorced from her husband, John Benjamin Eager).

The 1920 census for precinct no. 1, Harris County, Texas lists **Joe McGee**, age 65, a merchant; his wife, Emma, age 62, a housewife; a son, Richard Carson, Jr., age 12; a daughter, Francis Carson, age 4; and a daughter, Effie Carson, age 2.

(Note: The father of the children shown living in the Joe McGee household in 1920 was Richard Carson, but it is not known what his relationship was to the McGee's. The 1910 census for Bexar County, Texas listed Richard N. Carson, age 31, a section foreman for the railroad, b. in Ohio; his wife, Effie J., age 20, b. in Texas; a daughter, Maggie, age 4, b. in NM; and a son, Richard, Jr., age 3, b. in Texas. The 1920 census for Houston, Harris County, Texas listed Richard N. Carson, age 45; wife, Effie, age 35; and a daughter, Maggie, age 14, on page 64B, family #753. Joseph and Emma McGee, along with the three Carson children, were listed on page 63B, family #732. By the time of the 1930 Houston, Harris County census, the son, Frances Carson, now age 14, a 12 year old daughter, Julia, and most likely the 2 year old Effie from the 1920 census, had all returned and were living in the household of their parents, Richard and Effie Carson.)

"Joseph Flood McGee had been a farmer, a carpenter, a marshal in Old Dime Box and lastly a clerk in a small store that he and his wife owned on Cornish Street in Houston. Joe McGee died in St. Joseph's Hospital, Houston, Texas. The cause of death was cancer that ate away a good portion of his face before it finally reached his brain. He is buried at Forest Park Cemetery in Houston, Texas." (from descendant, Darrell Reider).

"Great grandfather McGee owned a very large ranch in Alief, Texas. My Dad (Lawton Eager) stayed with him and great grandmother frequently when he was little. I remember my Dad telling us the story about great-grandfather chasing him around the outside of the house trying to spank him. He was running as fast as he could, and great grandfather got tired, so he just backed up to the side of the house and every time Dad would run past, he'd pop him with the belt." (from descendant, Kathryn O'Gea).

Note: Joseph and Emma McGee are shown as having had seven children, but census records indicate that there were three additional children who died as infants. There is an old newspaper clipping with the date and header information missing in the possession of a descendant, Kathryn O'Gea, which states that "Rose Bee McGee, infant daughter of Joe F. and Emma J. McGee, died on October 20 at 3:00 a.m. She had been ill for only a few days."

Joseph Flood McGee died at his home in Houston, Texas on October 25, 1928. He suffered from cancer which severely disfigured his face.

McGEE – Funeral services for Joseph F. McGee, 76, of 2101 Reinerman Street, who died at his home at 9:30 p.m. Thursday, will be held at the Fogle-West funeral chapel at 3:30 p.m. Saturday, Rev. Koken officiating. Burial will be in Forest Park Cemetery under direction of the Fogle-West company. He is survived by his wife, Mrs. J. F. McGee; four daughters, Mrs. B. P. Loftin, Mrs. A. R. Eager, Mrs. Sammie Sorsby and Mrs. G. D. Warner; two sons, Kirby F. and J. B. McGee; 10 grandchildren and one great-grandchild. Active pallbearers will be Earl Fugate, I. F. Warner, Robert Schultz, Frank Earnest, S. T. Beck and A. J. Schrieber. Honorary pallbearers will be W. F. Wilson, Algin Warren, E. J. Perron, F. J. Earnest, C. W. Parodoski and W. W. Bright.

Notes for EMMA JOSEPHA MORRIS:

Emma's father, William Jackson Morris, moved his family from Mississippi to Louisiana about 1861, and then on to Texas after the Civil War, about 1866. In Texas they first lived in Fayette County, then Refugio County where Mr. Morris ran a girl's college. His second daughter (Emma's older sister), Alief Ozelda Morris, was one of the teachers there. It is believed that Emma's mother, Cassandra (Middleton) Morris was killed when a hurricane destroyed the college. Mr. Morris then moved his family to San Antonio, Texas, and it was there that Emma first met Joseph McGee. They were married in San Antonio in the home of Emma's father on December 23, 1880.

The 1870 census for Lyonsville post office, between Halletsville Road and Buckner's Creek, Fayette County, Texas lists W. J. Morris, age 51, head, a teacher; his wife, C. R. Morris, age 42, keeping house; L. Z. Edwards, age 25; her children, Lola Edwards, age 4, and Clement Edwards, age 1; a daughter, Ozelda Morris, age 18, a teacher; a daughter, Laura Morris, age 16, at school; a daughter, Emma Morris, age 11, at school; a daughter, Christina Morris, age 6; a daughter, Ada, age 4; and a son, Eugene Morris, age 1.

The 1880 census for Precinct No. 13, Bexar County, Texas lists W. J. Morris, age 60, a doctor of medicine; a son, W. P., age 23, a farmer; a daughter, **Emma**, age 20, a teacher; a daughter, Christina S., age 15, keeping house; and a daughter, Ada Ione, age 14, keeping house.

Between 1880 and 1900, Joseph F. McGee and Emma Josepha Morris had a total of ten children together, seven of whom lived to adulthood.

Emma McGee, age 71, a widow, was listed in the residence of her daughter, Inez Warner, during the 1930 census for Precinct No. 1, Houston, Harris County, Texas.

Last Rites Scheduled For Aged Resident

Funeral services for Mrs. Emma McGee, 88, of 4806 Old Spanish Trail, a resident of Houston 50 years, will be held at 10 a.m. Tuesday in the Fogle-West Chapel. Burial will follow in Forest Park Cemetery.

Mrs. McGee died Sunday morning in Dallas while visiting her daughter, Mrs. Alice Eager. She was a member of the Lawndale Baptist Church.

Survivors include three daughters, Mrs. W. T. Searcy and Mrs. B. P. Loftin and Mrs. Eager; a son, J. B. McGee, all of Houston, and a brother, Eugene Morris of Kerrville; 14 grandchildren and 10 great-grandchildren

Notes for BRYANT MCGEE:

Bryant McGee owned a drug store in Coppell, Texas. He was killed in his place of business when the soda fountain CO² tank exploded. The couple had only been married for three years when his death occurred. They had no children.

BRYANT MCGEE DEAD

The untimely death of Mr. Bryant McGee of Coppell was a great shock to the community. Thomas Bryant McGee was born in Kentucky, June 26, 1892, and at the age of five or six years he moved with his parents to Houston, Texas. On June 5, 1915 was married to Miss Minnie Bullock. Met death by accident in his own place of business at Coppell, August 3, 1918.

Mr. McGee was a kindhearted, generous man who made friends of those who knew him. His death was a great blow to his young wife with whom he had lived happily so brief a time. Also to his father and mother and other near relatives. A great throng attended the funeral which was held under the tabernacle at the Baptist Church at Coppell Sunday afternoon. The music was led by Mr. Cook of Grapevine; prayer was offered by Rev. Harrison also of Grapevine. The sermon was preached by Rev. Phillips of Carrollton, who was a close personal friend of Mr. McGee. The burial services were conducted by the Woodmen, of which the deceased was an honored member.

May God's grace sustain those who are so sorely bereaved by the sudden death of this most splendid young man. – A Friend

Notes for MINNIE BULLOCK:

McGee family oral history says that Minnie (Bullock) McGee had to be institutionalized shortly after Bryant McGee's death for an unknown length of time. However, by 1930, she had returned to Coppell, Texas and was running the family drug store.

The 1930 census for Precinct No. 8, Dallas County, Texas (Coppell and Lewisville Road area) lists Minnie B. McGee, age 38, head, a widow, with the occupation of a druggist in a drug store. According to the census record, she had been married at age 25 and she owned her home which was valued at \$1000.

The 1920 census for Houston, Harris County, Texas lists Bailey R. Loftin, age 42, head of the household, a house carpenter, his wife, **Ozelda R**., age 36, a daughter, Ozelda E., age 16, and a daughter, Mary L., age 14.

Texas Death Records, 1964-1998 lists Bailey P. Loftin, died 25 November, 1966 in Harris County.

Although in reality she was actually separated (or divorced) from her husband, the 1910 census for Houston, Harris County, Texas listed Allie (McGee) Eager as a widow, living in the household of her sister, Ozelda Loftin, and her family. Allie had a son, Lawton Eager, who was living with her parents, Joe and Emma McGee, at the time of the census. Allie was employed as a sales lady in a dry goods store.

Allie McGee ran a boarding house at 412 Crawford Street in Houston, Texas near the railroad station.

The 1920 census for 3rd Ward, Houston, Harris County, Texas lists **Allie Eager**, age 34, divorced, head of the household, and a son, Laughton J., age 18, employed as a yard clerk with the railroad. Also in the household were ten roomers.
















