CHAPTER THREE – RICHARD DEERING MCGEE FAMILY

Generation No. 3

1. RICHARD DEERING³ MCGEE (*JOHN SIMPSON*², *JOHN*¹) was born October 08, 1843 in the state of Kentucky, and died November 22, 1905 in San Antonio, Bexar County, Texas. He married **CAROLINE LOUISE "CARRIE" REYNOLDS** January 02, 1867 in Guadalupe County, Texas, daughter of M. HENRY REYNOLDS and LUCINDA BRADFORD. She was born July 13, 1849 in Starkville, Oktibbeha County, Mississippi, and died December 25, 1943 in San Antonio, Bexar County, Texas.

Notes for RICHARD DEERING MCGEE:

Richard Deering McGee was named for Richard Deering, the minister who converted his father, John McGee, to the Methodist Episcopal Church in Salvisa, Kentucky in 1842.

Richard D. McGee was a volunteer in the Confederate Army during the Civil War. He served with the rank of sergeant in Company I, 3rd Regiment, Texas Infantry, Scurry's Brigade, Walker's Division, from his enlistment on December 28, 1861 until the war's end. (Source is Widow's Application for a Pension No. 28543, filed by Carrie McGee on July 27, 1914, approved on September 1, 1914.)

Richard and Carrie Reynolds were married by Richard's father, Rev. John S. McGee, on January 2, 1867, in Guadalupe County, Texas. Carrie's father, M. H. Reynolds, and brother-in-law, Sanford Brown, were the witnesses.

The 1870 census for Seguin, Guadalupe County, Texas lists **R. D. McGee**, age 24, born in Kentucky, head of the household and a farmer, his wife, Carrie, age 18, born in Mississippi; a son, John, age 3, and a son, Robert, age 1. Both children born in Texas.

The 1880 census for District No. 75, Guadalupe County, Texas lists **Richard D. McGee**, age 37, head of the household and a farmer; his wife, Caroline, age 31; a son, John, age 12; a son, Robert D., age 10; a son, Louis H. age 9; a son, Richard E., age 8; a son, Walter M., age 5; a daughter, Florence A., age 3; and a son, Joseph W., age 8 months.

Richard D. McGee was Justice of the Peace for Guadalupe County, Texas from 1880 until at least 1889. He also served as County Commissioner, Precinct 4, at least for the year 1896. He was also a Mason.

The 1900 census for Justice Precinct No. 3, Guadalupe County, Texas lists **Richard D. McGee**, age 56, head of the household and a farmer; his wife, Carie, age 51; a son, Walter M., age 25; a son, Jim A., age 18; a son, Roland R., age 15; a daughter, Ethel D. age 12; and a daughter, Bernice C., age 5. Also living in the household was a nephew, William D. Reynolds, age 10. According to the census record, the couple had had 12 children, 10 of whom were still living.

According to his obituary, Richard D. McGee died from throat cancer on November 22, 1905 at

the age of 62. He was buried at Concrete Cemetery located in Guadalupe County, Texas, near LaVernia, Wilson County, Texas.

Obituary of Richard D. McGee (the Seguin Enterprise, Seguin, Texas, November 24, 1905.)

Today at 10 A.M. at the Concrete Cemetery near LaVernia, the remains of ex-County Commissioner Robert Dering McGee will be laid to rest in the grave with Masonic rites and all who knew him will mourn with those who mourn. A Kentuckian by birth, he came here with his parents when a little child. His father was a Methodist minister and moved to this county on coming to Texas. The late Squire was married to Miss Carrie Louisa Reynolds, and nine children out of the twelve born to them are living. Cancer of the throat caused his death in San Antonio, and the end came suddenly, owing to the bursting of a blood vessel. His last words were of Guadalupe County and his friends. He died as he lived, a fine brave spirit, lovong his kith and kin, loyal to his friends and fearing his God. How can a man die better! May he rest in peace.

Obituary of Richard D. McGee (the San Antonio Daily Light, November 23, 1905)

I. D. McGee, aged 65 years, died at 8 o'clock last night at 326 South Olive street. Mr. McGee came to Texas when he was ten years of age and has been in this state nearly ever since. He served with distinction in the Civil War. Surviving him are his widow and nine children. John S. McGee of Southerland Springs; Robert D. McGee of this city; Richard D. McGee and Walter M. McGee of Guadalupe county; J. W. McGee of this city and James Ethel, Roland and Bernice, who were present when he died. The funeral will take place tomorrow morning in LaVernia under the auspices of Brahma Lodge No. 226, A.F. & A.M.

The Application for mortuary warrant states that Carrie McGee died at the home of her daughter, Mrs. Ethel Dorsett. The warrant was signed by her son, R. D. McGee, who gave his address as 1009 W. Summit Avenue, San Antonio, Texas.

Obituary - Bernice C. McGee - Masonic Home Dean

Bernice C. McGee never had a child of her own, yet she mothered more than 1000 children during almost 40 years of association with the Masonic Home and School in Fort Worth. "She gave her life to children," said her niece, Marie Dodson of Dallas.

McGee was killed Friday when she was struck by a truck while walking to a grocery store. She was 92 years old.

Services were held today at Porter Loring Mortuary, with interment in Concrete Cemetery in LaVernia.

A native of San Antonio, she was a graduate of Main Avenue High School and Southwest Texas State Teachers College, now Southwest Texas State University.

She then moved to Fort Worth and served 39 years at the Masonic Home and School as teacher, dean of girls and director of personnel. "She helped mother more that 1000 children during her tenure at the home," her niece said. "One of her former students became president of Georgia Tech, another president of Baylor University, another a district judge, and there were some doctors and others who made noteworthy names for themselves."

McGee earned her master's degree at Texas Christian University in 1943 while working at the school. Her thesis involved the school history, her niece said. "She found that not a single former student from the home had been dismissed (dishonorably) from the Army and that 25 percent had won commissions during World War II," Dodson said.

McGee was a charter member, past president and district governor of Altrusa International, a club for professional women. She was a member of Eastern Star Chapter 3 in San Antonio for 66 years, and an active member of the First Presbyterian Church. She had lived in San Antonio since she retired from the Masonic Home in 1960.

Survivors include four other nieces, Louise Peckham of San Antonio, Martha Parrot of Woodland Hills, Ca., and Leonie Pape of Seguin; and a nephew, the Rev. Thomas McGee of Austin.

Robert D. McGee Jr., Son of Former Deputy Sheriff, Shot Five Times (San Antonio Express, San Antonio, Texas, September 6, 1938)

Five slugs from a .41 caliber revolver about noon Monday killed Robert D. McGee, Jr., 38, attorney, World War veteran and son of a former deputy sheriff here, in a rooming house at 726 1/2 South Alamo Street, operated by the dead man's estranged wife.

Shortly after the shooting, a man who gave the name of Louis Haynes, 34, taxicab driver, roomer at the house, surrendered to police. Reconstructing events preceding the shooting from testimony of witnesses including Mrs. Sophie McGee, 33, estranged wife of the dead man and operator of the rooming house at 726 1/2 South Alamo Street, and her friend Mrs. L. L. Graves of the same address, police said McGee came to his wife's apartment a short time before the tragedy. Mrs. McGee said she dissuaded McGee from attempting any violent acts. McGee left, but returned about 15 minutes later and went to Haynes' room where Gordon Howell, 1607 Broadway, was visiting with Haynes.

According to Haynes, who surrendered to police, McGee burst into his room. He said the man was wielding something and made threatening movements. Haynes told police he then grabbed a revolver. The officers learned that six shots were fired. A long-bladed pocket knife was found near the dead man's body.

Haynes suffered a wound in the left thumb, apparently by one of the six bullets discharged from the revolver, police said.

Attendants at the Robert B. Green Memorial Hospital said that five bullets entered McGee's body. Two bullets entered the left chest; another the right arm and two went into the left shoulder.

McGee was the son of Robert D. McGee, Sr., former deputy sheriff under Albert West, Jr.

The younger McGee recently had returned from the veteran's hospital at Waco where he had been confined for several months.

On May 18 in the same rooming house, Haynes narrowly escaped death in a fusillade of bullets that also threatened the life of his daughter, Irene Hayes, 8, who was in his room eating breakfast. The child was in the house Monday at the time of the shooting.

It was learned Monday that after the first affair, McGee was disarmed by witnesses a short time later and he was booked at the police station for assault to murder. He had not been brought to trial and was sent to the hospital in Waco.

Justice of the Peace Raymond Gerhardt was conducting an inquest into Monday's shooting. He had not returned a verdict Monday night.

At the time of his death, McGee lived at 1009 West Summit Avenue.

Private funeral services will be conducted Tuesday morning.

Surviving, besides the parents, is a daughter, Ruby McGee, all of San Antonio. He was a native of San Antonio.

(Note: The next day's paper states that Louis Haynes had been released on \$500 bond. Discussing the murder, the article also says, "...McGee...had gone to see Mrs. Sophie McGee. When she refused to see him...McGee tore a screen door from its hinges and attempted to enter her apartment. Mrs. McGee fled and it was then the former husband went to Haynes' apartment and forced entrance.)

"He was aboard a B-24 on a bombing run to Stuttgart, Germany, with a secondary target at Friederichshafen. His plane was in bombing formation maintaining radio silence. The plane lost a supercharger and dropped back out of formation, and then, after losing a second one, they headed back to England. They were attacked by German fighter planes as well as anti-Air Craft guns and took a direct hit. The pilot was killed outright, and the co-pilot was mortally wounded. One tail gunner was killed. The other crew members managed to parachute from the plane, and Jody was trying to get a gunner forward. Another side gunner, Ned Daugherty, was standing there waiting to get out when they took another direct hit, and Jody was probably killed at that point. Ned managed to find the exit and jumped. After landing Ned was able to avoid capture for three months, walking over the Pyrenees Mountains into Spain and eventually made it back to England. I have his letter telling the details, and I correspond and speak to him and his wife regularly." (from Jody's sister, Elizabeth McDonnell Lancaster)

After attending public school in East Bernard, he studied one year at Schreiner Institute in Kerrville before transferring th the University of Texas, where he received an LL.B. degree in 1939. He began law practice in San Antonio that same year and practiced there the remainder of his life. On November 18, 1939, he was married to Ruby McGee; they had three children. Peace was named by Governor John Connally as a member of the University of Texas board of regents in 1967. He was chairman of the board from 1971 until 1973, and is credited with being the driving force in establishing the University of Texas at San Antonio. He was executive assistant attorney general for Texas and served on the state Democratic Executive Committee from 1956 to 1960. He was chairman of the Public Safety Commission and was a trustee of St. Mary's University. He was also a director of the San Antonio Livestock Exposition, the Texas Law Enforcement Foundation and the Sam Rayburn Foundation, and was vice president and general council of the Burke Foundation. Periodically he was a visiting professor at St. Mary's University Law School. He served on the board of directors of the First National Bank of San Antonio, Station KLRN-TV, and Southwest Airlines. During World War II he was in

the Marine Corps, from which he retired as a first lieutenant. Peace was an avid collector of Texana. His collection of some 900 books and 500 documents dating back to the 1700s was donated to the University of Texas at San Antonio. "I thought I would tell you something about my father's life. He was born in Pensacola, Florida when his father was stationed there. His mother, Carrie McGee Stoddard did not like being away from home and was expecting their second child, Richard Lee, so she returned home to her parents in Texas. J. C. Stoddard never saw his father beyond the age of 1 and a half and neither did his brother, Jack. He came back once before Jack was born and tried to get Carrie to return with him, but they were unable to work it out and were divorced.

"J. C. had rheumatic fever and spinal meningitis as a child and was not able to walk for about a year. However, he had a strong will to survive and went on to become a star athlete in high school. He was captain of the Sayers High School "Bulldogs," who were the 1937 Rural Basketball Champions. He also won track ribbons in the 100 yard dash, the 220 yard dash, the javelin throw and the 220 yard hurdles. At the age of 19, he lost two fingers and part of his right hand in an accident at a clay factory where he was working. Some doctors recommended removing his hand, but one doctor was able to save it. My mother's parents didn't want them to marry because they thought he would not be able to work and provide a living with his injured hand, so they eloped to Floresville as my mother was underage.

"My father wanted to join the military, but when the doctors saw his hand, that was it for the military. He learned to sling a hammer, and as his part of the war effort, he worked in ship yards in Washington State. I was told by my mother that he worked so fast and hard that they made him slow down because the work was getting ahead of schedule. He worked as a carpenter for many years and then as a job superintendent. In 1974, he and his two sons, Curtis and Keith, started the Stoddard Construction Company which built shopping centers, schools, churches, jails, and many special projects such as part of Sea World and a meat processing and packing plant.

"J. C. Stoddard was paralyzed by a stroke on the right side of his body, and he lived this way for over 10 years. He had heart surgery at the age of 65 which was successful, but recovery was long as he contracted pneumonia while in the hospital. Later he had to have gall bladder surgery, and it was during recuperation of that surgery that he had a stroke. He was also discovered to have Addison's disease. Despite all of his health problems, J. C. lived to be 81 years old due to the loving care of his wife, Evelyn. He loved his wife, children and grandchildren." The official citation sent by Stoddard to his mother read: "During an advance on strong enemy positions in rugged, mountainous terrain, Cpl. Stoddard, on his own initiative, deliberately exposed himself to the enemy to draw fire. This bold action enabled his platoon to get into position to attack."

The citation was signed by Lt. Col. Leonidas Gavalas, A.G.D. at the order of Maj. Gen. Allen. In the Army about three years, Stoddard was with one of the first divisions to land in North Africa.


